2) revenue from our 2010 fundraising Gala;
3) three grants in 2010 that funded our grantmaking programs.

Fiscal sponsorship - 20 groups
In 2010, Potlatch Fund was able to offer fiscal sponsorship to 20 emerging Native-led nonprofit organizations in the Pacific Northwest. We offer this service to Native organizations that are in the process of seeking their tax-exempt status so that they may begin applying for grants. During this fiscal year, these 20 groups brought in \$201,354 in revenue which otherwise may have not come to Native communities.

Technical assistance - 40 trainings/workshops/conference presentations throughout the Pacific Northwest and elsewhere in the United States. At least 600 people were training participants and countless others benefited from conference presentations. Topics covered:

3. Financial Management for Nonprofits,
4. Board Governance & Strategic Planning, Media Management.
