### **Eligibility Requirements\***

The applicant **must**

1. be an enrolled citizen of a U.S. federally American Indian Nation, or
2. be an enrolled citizen of a state recognized American Indian Nation, or
3. be a current shareholder of an Alaska Native Corporation, or
4. have current documentation of Native Hawaiian ancestry.

The applicant, filing this application, meets the eligibility requirement listed above.

- Applicants will be asked to upload proof of enrollment within the Request for Proposal (RFP).

### **Applicants must meet the following criteria\***

1. **Must** serve Native peoples in Potlatch Fund's four state region of Idaho, Montana, Oregon, and Washington.
2. **Must** reside in Idaho, Montana, Oregon, or Washington.
3. **Must** have an artist statement that is aligned with the mission of Potlatch Fund.
4. **May only** receive funding for one Potlatch Fund grant per calendar year.

The applicant filing this application meets the additional criteria listed above.

**IMPORTANT** – To encourage sustainability, going forward, applicants that receive three years of consecutive funding must sit out one year. Count will start with 2018 grant awards.

For example:

2018 applicant XYZ receives a Potlatch Fund grant (Year 1).

2019 applicant XYZ receives a Potlatch Fund grant (Year 2).

2020 applicant XYZ receives a Potlatch Fund grant (Year 3).

2021 applicant XYZ cannot submit an application to Potlatch Fund.

2022 applicant XYZ may submit an application to Potlatch Fund - would become Year 1 if successful.

### Final Report Requirement\*

Native Artists, who have previously received a Potlatch Fund grant, may only apply to this grant cycle if they have completed all past reporting obligations.
